Re: 2023 Racial Profiling Report

Dear Councilmembers,

Each law enforcement agency in Texas, who conducts traffic stops, is required to keep statistics of the stops. A law enforcement agency shall compile and analyze the information contained in each report received by the agency under Article 2.133. Not later than March 1 of each year, each law enforcement agency shall submit a report containing the incident-based data compiled during the previous calendar year to the Texas Commission on Law Enforcement and, if the law enforcement agency is a local law enforcement agency, to the governing body of each county or municipality served by the agency.

Attached you will find the 2023 Racial Profiling report and the Comparative Analysis for the Lufkin Police Department.





Criminal Investigations Division



The Criminal Investigations Division is comprised of 12 detectives and 2 civilian crime scene technicians who also maintain the property room and catalogue evidence.

Detectives work 10-hour shifts from 6A-5P with weekends and off-set Fridays and Mondays off. Detectives and supervisors rotate a week of being on-call.

A lieutenant oversees the Criminal Investigations Division with the help of a sergeant and corporal.

Communications Division

The Communications Division is comprised of 12 dispatchers and dispatch supervisor who answer emergency and non-emergency calls for Lufkin Police & Fire. The Communications Division also dispatches for Lufkin ISD, Angelina College, and Pineywoods Community Academy Police Departments. In 2023, they assumed Diboll Police Department dispatch command.

Dispatchers are assigned to the same shifts as officers and work with a shift minimum of 3.

Records Division

Two clerks and 1 supervisor comprise the Records Division, housed inside Lufkin Municipal Court. They maintain the Department's database, input reports, and fill records requests for incident reports and crash reports for citizens. They are in the office M-F from 8A-5P.

There is 1 civilian Public Information Officer who answers Open Records Requests and media inquiries. They are responsible for the Department's Daily Media Report and social media presence. They are in the office M-F from 8A-5P and on call 24/7/365.

Professional Standards/ Recruiting Division

There are 2 Professional Standards investigators. They are responsible for taking and investigating citizen complaints, use of force and pursuit reviews, and the Department's recruiting and hiring practices. They work the same schedule as the Criminal Investigations Division.

Special Response Team

The Special Response Team is a unit of highly trained and specifically equipped officers who work as a coordinated unit to resolve critical incidents that are so hazardous, complex or unusual that they may exceed the capabilities of first responders or investigative units. Those incidents include, but are not limited to, hostage taking, barricaded suspects, snipers, terrorist acts and other high-risk incidents. SRT consists of 3 operational components: a Crisis Negotiation Team, the Entry Team, and the Sniper Team. The team is led by 1 commander.


This unit is also used to serve high-risk warrants, both search and arrest, where public and officer safety issues warrant the use of such a unit.
